1. PGDM – AICTE Approved (Bangalore Campus)

Tuition Fee: **Rs. 9, 50,000** (which Includes Free Laptop*& International Tour*)

Fees break up in Installments

Registration Fee & Processing Fee – Rs. 1,00,000/- To be paid at the time of Admission
(Non Refundable)

1st Installment – Rs. 1, 00,000/- within 30 days after paying Registration Fee

2nd Installment – Rs. 3, 00,000/- by 15th June 2026

3rd Installment – Rs. 2, 75,000/- by 5th February 2027

4th Installment – Rs. 1, 75,000/- by 5th October 2027

Other fees and expenses for Bangalore Campus for July batch.

Break up of Other Fees = 45,000

Placement Training fees: Rs.12, 000/-per year to be paid with 2nd and 3rd installment
(12*2=24,000)

Alumni lifetime membership fees: Rs.10, 000/- (Onetime payment to be paid with 2nd installment)

Library fees: Rs.5, 000/- (Onetime payment to be paid with 2nd installment)

Uniform fees: Rs.6, 000/- (Onetime payment to be paid with 2nd installment)

(Non Refundable)

1st Installment – Rs. 1, 00,000/- within 30 days after paying Registration Fee

2nd Installment – Rs. 3, 00,000/- by 15th June 2026

3rd Installment – Rs. 2, 75,000/- by 5th February 2027

4th Installment – Rs. 1, 75,000/- by 5th October 2027

HOSTEL FEES STRUCTURE

Hostel Fees Bangalore – Airport Campus @ Ozone Urbana (Boys & Girls)

- Hostel Caution Money: Rs 25,000/- (50% Refundable) Condition Apply*
- Boys & Girls: Rs. 15,000 /- Per Month ($15,000 \times 12 = 1,80,000$) Per Year (Twin Sharing)
- Boys & Girls: Rs. 20,000 /- Per Month ($20,000 \times 12 = 2,40,000$) Per Year (Single)

Hostel Fees Bangalore – Airport Campus @ Infinity (Only For Boys)

- Hostel Caution Money: Rs 25,000/- (50% Refundable) Condition Apply*
- Boys : Rs. 12,500 /- Per Month ($12,500 \times 12 = 1,50,000$) Per Year (Twin Sharing)
- Boys : Rs. 18,000 /- Per Month ($18,000 \times 12 = 2,16,000$) Per Year (Single)

Hostel Fees Bangalore – Airport Campus @ Begur Hostel (Boys & Girls)

- Hostel Caution Money: Rs 25,000/- (50% Refundable) Condition Apply*
- Boys & Girls: Rs. 8,000 /- Per Month ($8,000 \times 12 = 96,000$) Per Year (Triple Sharing)
- Boys & Girls: Rs. 10,000 /- Per Month ($10,000 \times 12 = 1,20,000$) Per Year (Twin Sharing)
- Boys & Girls: Rs. 15,000 /- Per Month ($15,000 \times 12 = 1,80,000$) Per Year (Single)

TRANSPORTATION FEES

- Bus Fee: Rs 25,000/- Airport Campus to Ozone Urbana Per Year
- Bus Fee: Rs 25,000/- Up to 10 Kms per Year
- Bus Fee: Rs 30,000/- 11 Kms to 15 Kms per Year
- Bus Fee: Rs 35,000/- 16 Kms to 20 Kms per Year
- Bus Fee: Rs 40,000/- 21 Kms to 30 Kms per Year
