Introduction

The Institute of Liver and Biliary Sciences (ILBS) has been established by the Government of the National Capital Territory (NCT) of Delhi as an Autonomous Institute, under the Societies Registration Act - 1860, at New Delhi. ILBS has been given the status of Deemed-to-be-University by the University Grants Commission (UGC) of India.

MHRD approved NIRF (National Institutional Ranking Framework) Year 2024 based on broad parameters like "Teaching, Learning and Resources," "Research and Professional Practices," etc has given an all India rank of 34 to ILBS in category 'Medical'.

The Institute of Liver and Biliary Sciences (Deemed-to-be-University) has been accorded with the 'A' Grade by National Assessment and Accreditation Council. The mission of the Institute is to become a dedicated international center of excellence for the diagnosis and management of liver and biliary diseases and to provide advanced training and research in the field of Hepato-biliary Sciences.

Qualifications Required for Degree/ Diploma Courses

a) DM Hepatology

MD in General Medicine or Pediatrics from an Indian University recognized by the Institute or Diplomat of National Board in General Medicine / Pediatrics or any other examination approved by the Institute for this purpose from time to time.

The candidates should have passed the MD exam prior to the date of entrance examination failing which they will not be allowed to appear for the entrance examination. In case the candidate is waiting for the results, unable to enclose the pass certificate, he / she can mention the same in the application and will have to submit the pass certificate compulsorily to the Associate Dean/Assistant Registrar prior to departmental assessment.

b) DM Organ Transplant Anaesthesia and Critical Care

MD in Anaesthesia or Diplomat of National Board in Anaesthesia or any other examination approved by the Institute for this purpose from time to time.

The candidates should have passed the MD exam prior to the date of entrance examination failing which they will not be allowed to appear for the entrance examination. In case the candidate is waiting for the results, unable to enclose the pass certificate, he / she can mention the same in the application and will have to submit the pass certificate compulsorily to the Associate Dean/Assistant Registrar prior to departmental assessment.

c) DM Pediatric Hepatology

MD in Pediatrics or Diplomat of National Board in Pediatrics or any other examination approved by the Institute for this purpose from time to time.

The candidates should have passed the MD exam prior to the date of entrance examination failing which they will not be allowed to appear for the entrance examination. In case the candidate is waiting for the results, unable to enclose the pass certificate, he / she can mention the same in the application and will have to submit the pass certificate compulsorily to the Associate Dean/Assistant Registrar prior to departmental assessment.

d) M. Ch Hepato-Pancreato-Biliary Surgery

MS in General Surgery from an Indian University recognized by the Institute or Diplomat of National Board in General Surgery or any other examination approved by the Institute for this purpose from time to time.

The candidates should have passed the MD exam prior to the date of entrance examination failing which they will not be allowed to appear for the entrance examination. In case the candidate is waiting for the results, unable to enclose the pass certificate, he / she can mention the same in the application and will have to submit the pass certificate compulsorily to the Associate Dean/Assistant Registrar prior to departmental assessment.

Admissions

Notification

The Institute of Liver and Biliary Sciences, New Delhi is a fully residential complex. All residents have to reside in the campus compulsorily. For admissions to the degree and certificate courses notification shall be issued in press by the Institute inviting applications from the eligible candidates to appear for entrance test to various courses. For admissions to the short courses the notifications would be posted in the ILBS website (www.ilbs.in) from time to time.

Instructions for Filling the Application Form

Candidates may download the application forms and prospectus from ILBS website www.ilbs.in. Candidates must ensure their eligibility from the prospectus before applying. Candidates should submit their application online at the ILBS website (http://www.ilbs.in). The applications for in-service candidates for sponsored seat must be routed through proper channel. The application fee is Rs.5000/- for PDCC and fellowship courses, Rs.2500/- for PGCC courses and Rs.1000/- for Ph.D. and Certificate Courses. The fee must be paid by net-banking/debit/credit cards. The application fee once paid will not be refunded even in case of his/her application is rejected.

Before submitting the application it is the responsibility of the candidate to ascertain whether they possess the requisite qualification for admission. Having been called for the entrance test does not mean acceptance of eligibility. Selection of the candidate will not be final unless the original certificates are verified and found correct and the fees are paid.

Application form should be filled up carefully by the applicant and no column should be left blank or incomplete.

All information given in the application form should be correct. Any false information or suppression of any factual information in the application would be a disqualification. In case any false information is furnished or that suppression of any factual information comes to the notice during any time of the course, he/she would be liable for appropriate disciplinary action including termination.

Pre-Requisites for Sponsored Candidates

A candidate who is sponsored by his/her employer and who meets the minimum eligibility criteria for the respective course may be permitted to appear in the entrance examination.

A sponsored candidate must have been in regular service of the sponsoring organization at the time of admission. The sponsoring organization must specifically undertake to provide full salary to the candidate and to relieve him/her to pursue the programme for its full duration. A certificate to that effect from sponsoring organization must be provided by the candidate at the time of applying for admission.

Upper Age Limit

For Degree/PDCC/PGCC and Certificate Courses: Forty years, relaxable by 5 years for SC/ST candidates. The age shall be determined as on the last date of the submission of application form mentioned in the advertisement.

<u>For Short Courses:</u> Fifty five years, relaxable by 5 years for SC/ST/overseas candidates. The age shall be determined as on the last date of the submission of application form mentioned in the advertisement.

Method of Selection for PDCC/Fellowship/PGCC/Certificate Courses

Selection of candidates for PDCC/Fellowship/PGCC/Certificate Courses will be on merit based on entrance test.

- Objective test (weightage 70%) for grading aptitude and merit. The test would be of 90 minute's
 duration comprising of 100 multiple-choice questions. The qualifying criteria for entrance
 examination is minimum 50% marks. To qualify for the departmental assessment for PDCC/PGCC
 and Certificate courses, the candidate should have secured minimum 50% marks in theory
 entrance examination.
- Departmental assessment and final interview (weightage 30%)
- Director's Interview
- Declaration of Final Result

Breaking Tie

The following criteria shall be adopted for fixing the merit of the candidates in case two candidates get equal marks in the entrance test in the following sequence:

- A candidate who passed MD/MS/DNB/MBBS with minimum number of attempts will begiven preference.
- Candidate who secures higher marks in MD/MS/DNB examinations will be given preference.
- Candidate who secures higher marks in Final MBBS examinations will be given preference.
- Candidate who secured higher marks in Medicine in MBBS examination in respective specialties. Elder in age will be preferred.

Note: - Candidates have to submit their MBBS/MS/MD mark sheet in case of break tie.

Stage I: NET qualified candidates with JRF Fellowship (Category-1 as per NET)

Applicants who have cleared a national level examination like CSIR/UGC-NET JRF, DBT-JRF, ICMR-JRF need to appear for a Direct Interview.

(Master's Degree in Biological Sciences (Biochemistry, Biotechnology, Life Sciences, Zoology, Microbiology) or a Professional degree (MBBS, Master Degree in Medical or Dental Sciences, M.Tech. M.Pharma M.V.Sc, declared equivalent to Master's degree by the corresponding statutory body. Candidates should have secured minimum 60% marks in aggregate or its equivalent grade as per UGC rules.

Stage II: The shortlisted candidates will be called for a round of interview to be held at ILBS.

Method of Selection for Ph.D. Nursing

Selection for Ph.D. registration will be made through 2-stage performance evaluation as under:

- Stage I: Non-NET Candidates fulfilling the minimum requirements would be invited for a competitive written qualifying test conducted at ILBS, Vasant Kunj, New Delhi. The question paper will consist of 100 multiple choice questions covering the syllabus relating to subject till the masters level. To qualify in the entrance examination candidate has to secure minimum 50% marks. The number of available seats will determine the number of students who will be called for interview. The interview ratio will be up to 1:5. The written exam serves only as a qualifying exam for interview/department assessment.
- Stage II: The shortlisted candidates will be called for a round of interview to be held at ILBS.

Other Information

The Entrance Test shall be conducted at ILBS, New Delhi.

- The candidates appearing for entrance test will not be paid any dearness / traveling allowance.
- The marks obtained by the candidates in the entrance test shall be displayed on the specified date.
- The selected candidate has to undergo a medical fitness examination conducted by the Institute. Candidates not found medically fit will have to forgo their admission, and the seat will be offered to the next candidate on the merit list.
- The selected candidates shall join the course by the date prescribed. In case the selected candidate does not report by the date, the next candidate in the order of merit will be selected in his/her place.
- The courses are full time courses. No postgraduate is allowed to do any private practice or consultation.
- The candidate seeking admission under sponsored category should apply through proper channel. The candidates are not permitted to register for any other Degree/Diploma courses and continue the studies, unless specifically permitted by the Institute.
- Duties and responsibilities of students joining the academic courses shall be fixed by the
 Institute from time to time. They will be required to pursue such works that may be needed
 in the legitimate interest of patient care in the hospital.
- The performance of the candidates joining the course will be evaluated at the end of every six months by a committee constituted for the purpose and in case of unsatisfactory performance, the Institute has the right to take appropriate action to extend the period of training or detain the candidate and make him/her ineligible for appearing for final examination including the removal of the name of the candidate from the rolls of the Institute.
- The candidates enrolled in DM and M.Ch. courses have to submit their thesis proposal cleared by the Institutional Ethics Committee to the Academic Cell within six month of the joining and candidates enrolled in PDCC courses have to submit their Research proposal cleared by the Institutional Ethics Committee to the Academic Cell within two months of the joining.

- The candidates admitted to degree courses, before being permitted to appear for the final examination shall be required to furnish proof of having undertaken research in the form of two papers in publishable format (one of them as first author).
- The candidate shall maintain a log book. There shall be entry of various procedures, operations performed, academic presentations done etc., by the candidate during the study period certified by the head of the department. This shall be submitted to the examiners at the time of practical and viva voce.

Attendance

Every candidate has to secure a minimum of 65% attendance in Institutional level seminar teaching and 75% attendance in Departmental level class room teaching. However, in exceptional cases the attendance requirement may be relaxed in the following cases only:-

- a) Students who have participated in University sponsored/approved activities for which necessary attendance will be given for the days of absence (i.e., number of classes) and the attendance will be calculated accordingly.
- b) In case of serious ailments when a student has to be admitted as an in-patient in a clinic/hospital as recognized by the University. In such approved cases, the number of classes missed will be deducted from the total classes held and attendance calculated accordingly.

Note:

- (i) In exceptional genuine cases, where the hospitalization is not necessary, the Institute will accept Medical Certificate from a qualified Medical Practitioner.
- (ii) The decision of the Examination Committee on the acceptance or otherwise of the Medical Certificate produced by the candidate shall be final.
- (iii) Candidates are required to submit medical leave forms along with medical record within a week of returning from the leave. No medical leave will be considered subsequently.
 - In case, it is found that any medical certificate submitted is false or not from the qualified authority / hospital, the matter will be referred to Disciplinary Committee.

After all these exceptions, if any candidate falls short of attendance, he/she will 'NOT BE ALLOWED' for the Examination.

Stipend

Monthly stipend as per the rules of the Institute will be paid to the candidates admitted to the DM/M. Ch course for 36 months and PDCC/PGCC for 12 months after taking their monthly attendance into consideration. Students enrolled for the certificate course courses will receive the stipend as applicable for the Junior Residents / JRF as per policy of ILBS.

Bond

The candidates admitted to PDCC courses shall execute a bond of Rs.2,00,000/- (Rupees Two Lakhs only) (Annexure I) on a stamp paper (non-judicial) of Rs.100/- value along with two sureties undertaking that in the event of the candidate discontinuing the studies at any time during the course, he/she shall be bound to pay/deposit bond amount as applicable. For this purpose, the original certificate of the students will be deposited and be returned only after paying the said bond amount. No Bond is required for certificate and Ph.D. Courses.

Closure of Admission

The admissions stand closed by the prescribed date and courses shall commence from the notified date. Due to unforeseen reasons if a seat falls vacant the candidates next in order of merit as per the rules will be considered for admission within the time frame. If a seat falls vacant for the sponsored seat, it will be filled from the General category.

The original certificates of the candidates shall not be returned till they complete the course of study and appear for the final examinations unless they discontinue the studies and fulfill the conditions of bond. Hence, they are advised to keep sufficient Xerox copies of certificates for their future use.

Powers of Dean/Associate Dean

Notwithstanding anything contained in these rules, the Dean/Associate Dean, ILBS may at any time before completion of the academic course, either on his/her own motion or on the application of any person after due and proper enquiry and after giving the person two weeks time from the date of receipt of the Show Cause Notice to submit the written explanation and on personal hearing, order the cancellation of an admission to the course, if in his/her opinion such candidate had furnished incorrect particulars/false information in the application or in the documents attached thereto or in the statement made either before the authority in charge of admission or the Dean / Associate Dean, or any other manner. Against any such order of the Dean / Associate Dean, the appeal shall lie with the Director, ILBS, New Delhi.
