

AMENITIES & FACILITIES

- ▶ The hostel is located on a lush 2-acre campus area and is near IFIM College campus. Transportation to and from the hostel is available at the campus. The hostel campus is completely wi-fi enabled and has well equipped single/double occupancy rooms, made available on first come first serve basis. Breakfast, lunch, dinner and tea are served at the hostel campus.

ELIGIBILITY CRITERIA

- The candidate seeking admission to the BBA LL.B programme should have appeared/passed pre-university/10+2 or equivalent examination from any recognized university or board.
- Minimum 45 % aggregate marks in 10+2 or 11+1 course or in an equivalent course as prescribed by the IFIM Academic Review Board from time to time in accordance with the requirement of the concerned regulatory body.
- Age to be below 21 years

LL.B

This course can be pursued after finishing any graduation degree, like B.com., BBA, BA, BSc to BEd. This course is a unique opportunity for most students to join a professional course.
