The clinic aims to train students about the nuances of the documentation and registration of IP rights and train them for professional endeavours through a handbook prepared by the Clinic.

Public International Law Research Centre

The mission of the Centre is to undertake academic research and create a platform for discussion and deliberation. Through its activities, the Centre aims to promote and explore the impacts of international law in this era of globalization. The primary goal is to ensure that

interest develops in different areas of international law and the expectation is to translate the interest into some form of research output.



Centre of Excellence for Women, Child, and the Law

The lab is research based and the fortunate students will be involved in activities ranging from Critiquing literature, watching motion pictures, learn problem solving, conduct multidisciplinary workshops, go on a journey of self-awareness, and apply these to influence the environment they live in. The whole of this chunk of activities will be recorded in Reflective Writing Journals. The rich experience from the events will enhance the interest to bring in broader perspectives towards the application of legal studies.

Hostel

The hostel is located on a lush two acre campus and in close proximity to the main campus. Transportation to and from the hostel is available at the campus. The hostel campus is completely Wi-Fi enabled with well equipped spacious rooms, made available on first-come-first-serve basis. Facilities for indoor and outdoor sports like Football. Library

The library, spread over 3000 sq ft area, amasses as much as 5000+journals, 18000+ dissertation reports, more than 4500 annual reports, 381 bound volumes and more than 400 A/V resources. It maintains an online information system designed to help students flip through online journals and other relevant resources.

Labs & IT

Our labs are designed keeping technological advances in mind. Withadvent in technology the onus remains on the platforms to provide resources to house cutting edge tools and resource intensive softwares. The infrastructure is secured and backed up with secondary power supply, thereby minimising all kinds of technical interruptions.

Sports

Clasroom

The Competition was inaugurated on the 25th of February 2022 which was followed by draw of lots, exchange of memorials and the researcher's test. Preliminary Round 1 was conducted on the same day. Preliminary Round 2, Pre-Quarter Final and Quarter Final Rounds were conducted on the 2nd day that is on 26th February 2022. The Semi Finals and Final round were scheduled on 27th February 2022.

Law schools are simmering with competition as more and more young minds gravitate towards careers in law. In such an environment, mooting is of utmost importance. Not only does it provide students with a break from classroom learning, but it also gives them opportunities to learn and grow. Mooting develops in students the essential skills of researching, developing innovative lines of argument in consonance with the law, drafting and withstanding the questioning of seasoned and learned judges, which they are bound to face in their future, no matter what line they eventually tend to tow. Mooting skills go a long way in transforming students into effective lawyers. Participating in moot courts is an irreplaceable part of one's experience as a law student.

A robust mooting culture is quintessential to any good law programme. Through various workshops and training on court mannerisms, etiquettes, how to draft a memorial, a student gets equipped with the necessary arsenal to participate in moot court competitions. The MCC or the Moot Court Committee of IFIM Law School has been innovating and implementing new and more effective means to reach out to the students of the law school as well as others, which has definitely resulted successful endeavours of the law school in both National and International Moot Court Competitions. IFIM Law School collaborates with veteran mooters and people from the legal fraternity to conduct regular webinars and training sessions so that students learn from real life experiences.
